

**Bramshill Parish Council
Minutes of a Meeting held at
The New Inn, Heckfield
on Tuesday 26th March 2019 7.30pm**

- 19/01 **Present:** SA, GS, NS, JG, and three parishioners
- 19/02 **Apologies:** Cllrs David Simpson, Tim Southern, Geoffrey Hamilton-Fairley, Maggie Sheerman, and Ann Crampton.
- 19/03 **Minutes of the Parish Council Meetings** held on 11th December 2018 already approved were signed by SA.
- 19/04 **Matters arising from the Parish Council Meeting of 11th December 2018**
Following a poor turnout from the parishioners at the December meeting SA suggested that this event needs to be addressed. Suggestions were made to have a speaker at the APA (Annual Parish Assembly) suggestions to be circulated by councillors by email.
- 19/05 **Bramshill House and Gardens:** The Chairman spoke of the appeal decision that all applications for new build and change of use of the manor house had been declined, there had been a period of up to 14th March to lodge an appeal, appeals have been made against some of the residential properties full details to be advised by HDC.
- 19/06 **Finance:**
GS presented the income and expenditure statement for January 2019 together with the grant figures showing a balance of £400.00 to cover long term costs, funds being held in the parish bank account separated out on the spreadsheet.
Cheques to authorise:
1) Glynis Spencer: - £320 for Parish Council duties January - March 2019
2) The New Inn, Heckfield: - £20.00 room hire.
The balance of the bank after outstanding amounts had been presented stands at £2335.84 including the grant balance of £400.00
GS advised that shortly the financial year end would be carried out and that once again Mrs Westlake would be asked to carry out the internal audit for us. All forms will be loaded onto the parish website and completed prior to the AGM & APA.
- 19/07 **Access/Highways:**
SA mentioned the disruption for residents that occurred during the water mains repair, the work was completed ahead of schedule.
JG objected strongly of the unannounced road closure by Hampshire County Council Highways Department in Heckfield for road repairs, causing residents to take diversions that were long and difficult for larger vehicles.

Development Certificate for an Existing use of building as self-contained single dwellinghouse. **Withdrawn**

(c) 18/02592/HOU Broom Cottage, New Mill Lane Eversley: Porch extension and two storey rear extension. Raise existing roof to increase ceiling heights of existing dwelling: **Refused**

19/10 **Crime:** Various fly tipping within the parish had been reported. NS spoke of a break in at a residential home in a neighbouring village.

Mr Vasey also mentioned that following the water board road repairs 6 identifying posts had been installed he had requested them to be removed which will take place shortly.
