- 23/13 **Election of Chairman for 2023/2024**Cllr Shaun Allison was elected as Chairman. Proposed by MS and seconded by AC
- 23/14 **Delivery of acceptance of office by councillors:** Declaration forms were signed by all members of the council and witnessed by the clerk.

### 23/17 **Finance:**

GS advised the council that the year-end accounts for 2022-2023 had been prepared and that an internal audit had been carried out. The closing figure at the year end was £3062.86. GS advised the council that this figure enabled BPC to proceed with exemption from an external audit. All councillors unanimously agreed to this route. The Certificate of Exemption -AGAR form and the agreed accounts were signed by the Chairman following the meeting and will be posted onto the parish website. GS also confirmed that the publication requirements will be posted onto the Parish Website on the date allocated. The latest income and expenditure figures had been circulated; GS advised that £2000.00 precept had been received.

#### 23/19 **Environment:**

Eviction notices had been issued by the former owners of Bramshill House, City and Country on all tenants of rented properties, six properties remain occupied to date. Planning Appeals relating to change of use of the accommodation blocks raised by City and Country had been withdrawn.

# 23/20 Crime: Neighbourhood Watch and Police Update.
