- 17/13 **Minutes of the Parish Council Meetings** held on 23rd January 2017, were approved and were signed by SA.
- 17/14 **Matters arising from Council Meeting of 23rd January 2017:**
14.1) Eversley Parish Council were unable to loan the Speed Indicator Device (S.I.D) due to the item being a fixed device but in future a portable device may become available.
14.2 The signage to indicate no HGV vehicles and single track road to be installed at the top of Ford Lane had been requested, DS confirmed delivery would be imminent.

15.1) 16/01290/FUL Granted at planning meeting in December. All other applications refused. Notifications of Appeal submission by City & Country had been received, SA confirmed a start date of end October with and end date of 5th December 2017.
