

**Minutes of a Bramshill Parish Council Meeting
Held at Eversley Cricket Club, Eversley Cross
on Thursday 27th March 2025 at 7.00pm**

25/01 **Present:** SA, NS, BC, MS, AC, and five parishioners.

25/02 **Apologies:** Cllrs Anne Crampton, Tim Southern & Tim Davies

25/05 **Finance:**

GS advised that the new bank account is almost set up.

The income and expenditure statement and cash book figures had been circulated.

25/06 **Access/Highways:**

NS and MS gave an update on emergency repairs to the Bramshill Road which caused major problems to residents, also causing road rage incidents and damage to Plough Lane and Ford Lane. Verges have been damaged and a residue of mud and gravel left on the road surface caused by diverted traffic. MS had reported this also contacting County Cllr Tim Davies. Highways have agreed to make good the roads. AC mentioned that there were still problems with grills MS to chase this via Fix My Street. NS mentioned further problems with wet areas close to Springwater Cottage in Ford Lane MS to report the problem areas.

BC spoke of an adjoining parish problem regarding a potential new motor cross site close to the boundary of The Pheasantry.

25/07 **Environment:**

GS had circulated details of recent planning applications from the last meeting. One outstanding planning application councillors to email comments to clerk.

25/08 **Crime: Neighbourhood Watch and Police Update.**

No crimes to report, more regular fly tipping.

25/09 **AOB:**

MS mentioned the Rag Wort which is growing freely on the land at the junction of Plough Lane and Bramshill Road owned by Linden Nurseries. It was agreed that a letter be sent from the council requesting this be taken care of prior to blooming.
