24/24 **Finance:**

The parish official documents had been circulated to all councillors for review. No comments were made and will be reviewed again at a later date.

GS advised the council that the year-end return for 2023-2024 had been completed following the guidelines and all documents have been posted to the parish website. The latest income and expenditure figures had been circulated.

24/25 **Access/Highways:**

25.1 SA mentioned the repairs to the flooding at the Bridge on Bramshill Road caused by blocked drains and ditches was inadequate and needed further attention. TD to chase James Holt from Hampshire Highways (HH). NS to liaise.

24/26 **Environment:**

GS had circulated updated details of outstanding planning applications. Councillors to email the clerk a decision on the recent outstanding application.

24/27 **Crime: Neighbourhood Watch and Police Update.**

Fly-tipping still a problem with Plough Lane recently blocked. MS remarked that following a call to report the problem of fly tipping the council are quick to clear the site. TD advised the council that the new police station in Yateley has an opening date of November 28th.
